Privacy Policy for Links

We may use your data for analytics, but we do not sell, lease, or rent your personal data to third parties for commercial purposes.

4. Data Sharing and Disclosure

We do not sell, trade, or share your personal information with third parties for marketing purposes. However, we may disclose your information under the following circumstances:

- **Service Providers**: We may share your information with trusted third-party service providers who assist in operating the App, such as hosting, analytics, and customer support. These providers are bound by agreements to keep your data confidential and secure.
